Last week cattle sold for \$110.00 cash and \$170.00 dressed. There were also several large cattle in Iowa/Minnesota selling down to \$104.00. These are cattle that were put on feed and then in the spring during the height of the packer slowdown taken of feed and moved to pastures. They came back as bigger boned and larger animals that either did not finish out Choice or if they finished Choice, they were too big and were discounted. It was noticeable in the way weights have increased, how Select boxed beef has dropped compared to Choice and the drop in dressing percentage.

Eventually, cattle weights will not have had difference. By December should see weights normalize. Into 2021, wide differences should be gone


It will be important to watch Select boxed beef movement over the next week. The US cattle industry is known for Choice and Prime beef. Putting too much Select on the market especially if it takes time to clean it up, could weigh on prices. However, it could help exports to markets wanting the Select products over Choice. It likely will weigh on the Choice cuts that go to ground beef and trimmings.

Hog weights are not going down. Slaughter is up 1.1% year to date and for the week kill is 33,000 head more compared to a year ago during the same week.

Hams that have been leading the cutout higher ended up lower than for the week and lower than the five day average. Hams for the week were down \$6.62 compared to a week ago and down \$3.43 on the five day average. Loins were higher on the week up \$3.45 and on the five day average up .90 cents. Butts picnics, ribs and bellies were all higher.

Hams need to maintain the strength in the market unless loins can take over, but loins have not been the reason for the stronger cutout.
