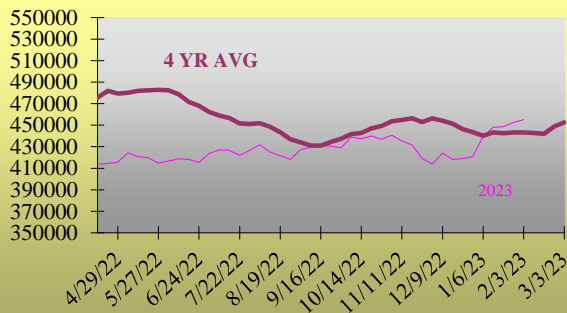

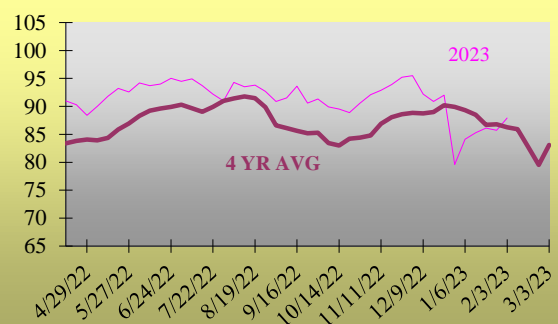

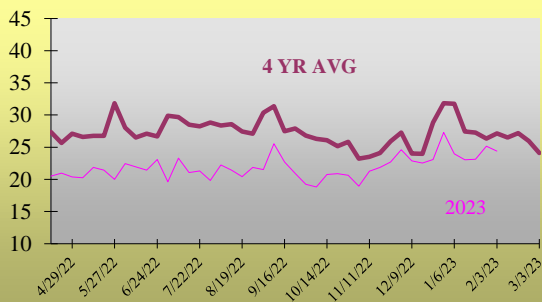

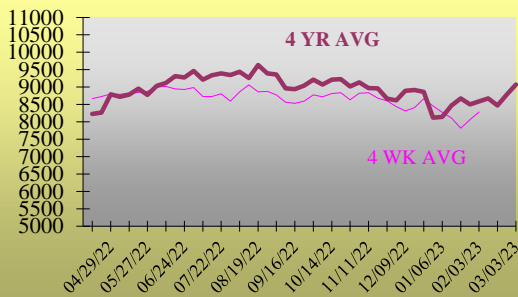


HEATING OIL DEMAND

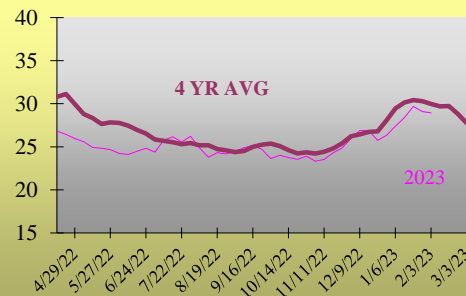
